A Liability of Insurance not less than one-million dollars is required if it is a Publicly Announced/Advertised event.

I agree to maintain the cleanliness of the facility during my use, leaving the facility in the condition in which was upon my entering.

**Park Hours of Operation:**

Park operations are noted below unless otherwise approved by the Director of Public Works.

- Robert Cross Park will open at dawn (daylight) in the mornings seven days a week, therefore; the exact time of opening will vary as the season changes. Park patrons are not permitted in the parks before dawn. Restrooms are open from 8:30 am till 6:30 pm.
- Robert Cross Park will close at dusk (dark) in the evenings seven days a week; therefore, the exact time of closure will vary as the seasons change. Park patrons are not permitted in the parks after (dusk) dark.

**Reservation Availability and Fees:**

- Picnic shelters and uncovered tables are available on a first come, first serve basis, unless reserved in advance.
- Reservations are on a “first come-first pay” basis and can be made 11 months in advance of the date.
- Picnic Shelters are \$40.00 for the day
- Picnic Tables Uncovered are \$10.00 for the day
- Fishing at the pond – No Charge (*No Swimming Permitted*). *A current Georgia DNR fishing license is required by state law at public facilities.*

**Park Rules and Patrons’ Responsibilities:**

- Park guests must supply all items necessary for their reservation (*tables, chairs, decorations, grills, etc*) with approval by Dougherty County Public Works staff prior to the reserved date.
- Grills and running water are provided at each shelter. Shelters do not have ELECTRICITY.
- Guests may bring in ONE personal grill only. The park gate will be unlocked between 8:30 a.m. till 9:30 a.m. for the grill to be dropped off at the shelter. Then, the patron’s vehicle must be immediately removed to a designated parking area. The gate will be unlocked again at 6:30 pm to take personal grills out of the park.
- **NO SELLING** of any goods or food items within the park.
- **NO VEHICLES** permitted within the Park. (*Examples of vehicles include, but are not limited to Cars, Trucks, SUVs, Motorcycles, 4-wheelers, golf-carts, etc*) All vehicles must be parked in designated Parking Areas.
- **No Alcoholic Beverages Permitted in Park**
- All Park Patrons are required to help keep the parks clean and litter free. Anyone who abuses park facilities or equipment may be asked to leave and/or may be subjected to criminal prosecution.
