Dear Counsel:

As you know, the Courts are continuing our efforts to reduce the spread of COVID-19 by eliminating large gatherings whenever possible. Until further notice, I will not hold any large in-person arraignments as in the past. Instead, I am requesting defense counsel to assist the Court's efforts by filing a written waiver of arraignment as a safer alternative.

Attached is a list of cases that have not been arraigned. Please file a written "Waiver of Arraignment" with the Clerk and serve a copy on the assigned District Attorney or Assistant by **August 3, 2022**.

If you do not waive arraignment by that date, please advise my assistant, Candee Nix at [canix@dougherty.ga.us](mailto:canix@dougherty.ga.us), whether you want to be scheduled for a formal arraignment or a negotiated guilty plea.

At this time both formal arraignment and guilty plea proceedings will be conducted by video conference and recorded by my official court reporter. In each case, I will issue an order which requires defendants, their counsel and prosecutors to participate. Defendants who fail to appear and participate in arraignments conducted by video conference will be subject to arrest bench warrants for failure to appear.
