Dear Counsel:

As you know, the Courts are continuing our efforts to reduce the spread of COVID-19 by eliminating large gatherings whenever possible. Until further notice, I will not hold any large in-person arraignments as in the past. Instead, I am requesting defense counsel to assist the Court's efforts by filing a written waiver of arraignment as a safer alternative.

Attached is a list of your pending cases that have not been arraigned. Please file a written *Waiver of Arraignment* with the Clerk and serve a copy to the assigned District Attorney or Assistant by **October 9, 2024**.

If you do not waive arraignment by that date, please advise my judicial assistant, Rhonda Moree at rmoree@dougherty.ga.us whether you want to be scheduled for a formal arraignment or a negotiated guilty plea. Formal arraignment will be conducted in person and recorded by my official court reporter. Guilty plea proceedings will be conducted by video conference. In each case, I will issue an order which requires defendants, their counsel, and the prosecutor to participate and instruct them on how to do so. Defendants who fail to appear and participate in arraignments will be subject to arrest warrants for failure to appear.
